

LMQ Consultation Projects

- <u>February 2019- to date</u>: upgrading the management system of the Emirates International Accreditation Center (EIAC) according to the requirements of the International Standard ISO/IEC 17011: 2017 version.
- October 2016 April 2018: Qualifying Chemical Defense Laboratories of the General Armed Forces of UAE (testing labs of water, food, Wastewater, radiation and textile) to achieve accreditation according to the international standard ISO/IEC 17025, by preparing the documentation of the laboratory management system, guiding the implementation of the documents and training on the requirements of the standard ISO/IEC 17025 and internal auditing.
